# **PRODUCT INFORMATION**

ENDURE MINI is a purpose-designed mini bait for application with seed when sowing crops. The mini bait ensures a high number of baiting points in the drill rows. ENDURE MINI bait kills slugs and snails by irreversibly destroying the mucus producing cells that are essential for movement.

# DIRECTIONS FOR USE

DO NOT apply to edible plant parts or to crops where baits may be collected with harvested commodities or animal fodder. DO NOT heap baits.

# **PROTECTION OF ANIMALS**

Store safely away from animals as accidental poisoning may be fatal. Keep poultry and pets, particularly cats and dogs, away from treated areas.
